

### Sovereign Order of St. John raises \$187,000 and assists 191 mentally ill clients through their Living Spaces program

Victoria, BC — Today the Victoria Hospitals Foundation announced that since the Sovereign Order of St. John, Victoria Commandery, launched its *Living Spaces* program in December 2007, the Order has donated a total of \$187,000 and assisted 191 mental health clients in Victoria. The *Living Spaces* program supports mentally ill clients either entering the transitional housing program or receiving services through the downtown Assertive Community Treatment (ACT) Teams. Clients are provided with the necessities of life such as beds, pillows, bedding and mattresses which they can keep as they move towards more independent living.

*“Living Spaces reaches one of Greater Victoria’s most vulnerable populations,”* said Leslee Farrell, chair of the charity committee, Sovereign Order of St. John, Victoria Commandery. *“We want to support these individuals as they are making the difficult move from homelessness to a hopefully more stable, improved life.”*

The Sovereign Order of St. John’s *Living Spaces* project originally worked through Vancouver Island Health Authority’s (VIHA) supportive housing program, which provides intensive 24-hour support and regular professional medical services to mental health clients. Clients of the program live in community-based apartment-style units in the Victoria area and may also receive living skills training and vocational rehabilitation.

Over the past year, *Living Spaces* expanded to include more of a downtown focus by supporting the Assertive Community Treatment (ACT) Teams. These teams focus on individual clients and their recovery by facilitating community living, psychosocial rehabilitation, and recovery for people who have the most serious and complex mental illnesses. Services provided by the ACT Teams are individually tailored to meet the needs of each client and are delivered by a mobile group of mental health staff from a variety of disciplines, working as a team.

*“Living Spaces is a fantastic example of a group of community-minded individuals getting behind a worthwhile cause to really make a difference,”* said Bill Thomson, board vice chair, Victoria Hospitals Foundation. *“We are grateful the Sovereign Order of St. John has made such a solid commitment to support this important program.”*

VIHA provides supportive housing to approximately 800 individuals in 24 separate facilities in the Greater Victoria area.
